- **2) Membership of the Club & PSCCT:** I understand that my membership of the Club is subject to payment of the applicable Club membership fee by the due date and the terms of the Club's constitution and that upon payment of my capitation fee I will also become a member of PSCCT, and that I will continue to be a member of the Club and PSCCT until I resign or my membership is otherwise terminated.

  - a) processing my application for membership, including the Club's compilation of its register of members in accordance with the Incorporated Societies Act 1908 and its constitution, PSCCT's compilation of a database of its members (accessible only by authorised members/staff of the Club and PSCCT) and the provision of Club membership details if required by Tennis Auckland and Tennis New Zealand;
  - b) publishing any of my results in emails, newsletters or other publications issued by, and on the websites of, the Club, PSCCT, Tennis Auckland and Tennis NZ;
  - c) selecting and naming publicly players, officials and teams to represent the Club at events;
